Understanding the spread and impact of a charismatic invader.

Wild Turkeys (Meleagris gallopavo) are certainly among the most interesting challenges introduced to California. Though native to other parts of North America, Wild Turkeys never successfully colonized California, and so the recent introduction and expansion of turkeys in California creates tantalizing questions and research opportunities. In November 2002, I initiated the first experimental assessment of turkey impacts in California. This exclusive experiment evaluates the effect of turkeys on vegetation structure and composition, acorn removal, and ground-dwelling invertebrate populations. Audubon Canyon Ranch's Turkey Invasion Program also includes a mapping project that will complete important gaps in the understanding of introduced turkey ecology. This presentation will give an overview of the history and biology of California's introduced turkeys and include presentation of ongoing turkey research.

Grizzly Island Field Trip Report

Clear skies and warm weather welcomed 15 birders and one guest of the Napa-Solano Audubon Society during their first field trip to Grizzly Island in several years. John Robinson led the group on a walk down one of the more popular birding levees, followed by various stops and walks of varying lengths along the main road going into the Grizzly Island wildlife area.

Thanks to the many spotting scopes that were on hand, everyone got great looks at the many ducks that were seen on this day, including: American Wigeon, Gadwall, Green-winged Teal, Mallard, Northern Pintail, Cinnamon Teal, and Northern Shoveler. One Bufflehead was seen but only by one or two people. We also got the opportunity to hear John talk about how to tell hawks and shorebirds from one another, in particular the Greater and Lesser Yellowlegs and the various swallows that frequent our area in the spring and summer.

One Great Horned Owl sitting on a nest, and another one seen later that morning in its favorite roost tree, formed the highlight of the trip for many of the Audubon members present.

DESTINATION LOCATION AND TIME:

We will meet at 8:30 am at the Solano County Education Bldg. across from Costco in Green Valley.

Barring any unforeseen event, we are planning to hike the trail to Green Valley Falls. On a level of 1-5 this would be considered a medium level 2-3 uphill hike. Wear suitable hiking shoes, bring a walking stick, dress in layers, bring liquids, snacks, a light lunch, and tick spray. This will be a morning hike ending after lunch.

This is a special outing for members of Napa-Solano Audubon. Green Valley Falls is not open to the general public. However with a permit and only with a leader who has completed the hiking course certification by the City of Vallejo, allotted days are available and we are one of the few to receive a allocation. Although Mike is qualified to lead this hike more than any instructor the city might have, he needs to be certified and will be going through the course on our behalf.

Green Valley Falls is like falling into another world. The first time I hiked it 20 years ago, I thought I was in the forest of Hawaii. Ferns line the lush valley, and you would never expect to see anything like it in Solano County. We will be seeing birds associated with woodland and riparian habitat.

Due to the limited number of people allowed on this trip, this trip is open only to "individual" Friends of the Napa-Solano Audubon Society. This does not include family members and friends. If the slots are not filled, members affiliated with Napa-Solano Audubon through the National Audubon Society may fill the remaining slots.

Since there may be more people wanting to attend versus the number of slots available, pre-register to be pre-selected by lottery. Send an e-mail to David Takeuchi to get on the pre-registry no later than Friday, May 6, 2005, Subject: NSAS Green Valley pre-registry. It is important that you state whether you are a Friends of the Napa-Solano Audubon Member, or a member of Napa-Solano Audubon via the National Audubon Society.

If you are not a Friends of the Napa-Solano Audubon Member and wish to join but are unable to do so before sending me an e-mail, let me know and I will accept your membership application and \$25.00 at the time we meet on Saturday morning at the Solano County Education Bldg. You can find the application on the Song Sparrow or on our web site. Those selected will be notified by email on May 8, 2005.

The City of Vallejo requires a photo ID, so bring your drivers license or State Issued ID with you. You will be required show your ID to sign in at the entrance to Green Valley Falls.

FUNDRAISING CAMPAIGN FOR APRIL 2005

By the time you read this you should have received a fund raising letter. The focus of this year's campaign is to greatly increase the number of Friends of Napa Solano Audubon Society. As many of you know we began this membership category in the Fall of 2004 as a way for members to direct their contributions to support local birding, local conservation education and advocacy, and local citizen science such as our Solano Breeding Bird Atlas. The response to the Friends membership has been very positive with over eighty chapter members becoming Friends to date raising over \$2000 for local chapter activities.

The fundraising letters were written specifically for three focus groups: Current Friends who joined in 2004 and now have an opportunity to renew their membership (80), current chapter National members who have not yet chosen Friends membership (550), and former chapter members whose National membership expired within the past six months. All were invited to either renew or initiate their support of the local activities of the chapter by becoming a Friend for only \$25. Friends memberships run from July through June each year.

As an incentive all were offered a copy of <u>both</u> the Napa county Breeding Bird Atlas <u>and</u> a copy of Best Birding in Napa and Solano County (3^{rd} Edition) for only an additional \$15. This year we hope to raise \$3000 in donations from this campaign.

As a reminder of how the Friends money has been spent so far, the fundraising letter also included a list of chapter accomplishments in 2004-2005.

Proposed By-Laws Changes

ARTICLE III MEETINGS

Section 2. The annual meeting of members shall be held on such date in June each year as may be determined by vote of the Board of Directors.

Change June to May

ARTICLE V OFFICERS

Section 5. The Vice President shall assist the President in the performance of duties, and in the absence of the President, the Vice President shall preside at any meetings.

Add additional sentence: The Vice President shall, in addition, be the Program Chair, unless with the concurrence of the President, the Vice President chooses any other open Chair.

ARTICLE VI ELECTIONS

Current Section 1. The election of officers shall take place at a regular meeting of the members one-month prior to the annual meeting. The officers shall be installed at the annual meeting.

Change entire paragraph: The election of officers shall occur at the annual meeting in May. The term of office runs until the end of June unless, following the election, the outgoing incumbent voluntarily relinquishes office to the newly elected officer.

ARTICLE VII COMMITTEES

PROGRAM COMMITTEE

The President shall appoint a Program Chair. It shall be the duty of this Committee to make all plans and arrangements for the regular meetings of NSAS.

Change entire paragraph: With the concurrence of the President, if the Vice President chooses to serve in an open Chair other than that of Program Chair, the President shall appoint a Program Chair. It shall be the duty of this Committee to make all plans and arrangements for the regular meetings of NSAS.

Add new committee:

COMMUNICATIONS COMMITTEE

The President shall appoint a Communications Chair. It shall be the duty of this committee to maintain a registered, hosted website or future equivalent, which will contain information on the meetings, field trips, projects, and officers of NSAS. In addition it may contain links, pages, and announcements that support the purpose and objectives of NSAS and National. The committee shall continue to seek up to date, cost effective means of disseminating information about NSAS to the public and membership. As long as any member specifically requests information by means other than electronic dissemination, the committee shall maintain a mailing list for those members and mail information on chapter events not less than quarterly to those members who have made such a request.

President's Perch (as in where a bird sits – not the fish)

The combined March and May board meeting was held on Wednesday, April 13th. As always there was a full agenda of action items. Pat Hildreth, Education Chair assisted by Cheryl Harris, Publicity Chair reported they had sent out forty invitations to Napa third grade classrooms to present a program they generated called Birding Adventures and received ten invitations to present in classrooms. The program is built in accordance with the California teaching standards. They gave their first presentation on Wednesday, April 13th and reported it was a great success. They said the kids wanted to know if they were coming back the next day too!

David Takeuchi, Field Trip Chair reported he had negotiated a fantastic deal with Eagle Optics to fulfill chapter needs for both light weight sturdy binoculars to be used in our youth programs and good quality field binoculars to be used on adult field trips. He arranged purchase of five youth binoculars for less than \$400 and Eagle donated an additional five. In addition Eagle agreed to sell us two high quality adult binoculars that normally cost nearly \$300 each for a total of \$500. Eagle also waived the shipping charges. Thus the chapter now has twelve new binoculars for less that \$900.

Dave McMullen was introduced as the new chapter Webmaster. He is a former high school teacher now working in insurance in San Francisco. He is an avid birder and has volunteered to cover Block G3 for the Solano Breeding Bird Atlas. David said his goal was to make the website responsive to the needs of the chapter and pledged to post information in a timely and clear manner.

The Board reviewed the FY 04 - 05 Actual v. Budget financial report and was pleased to see we have generated \$1700 more income than expenses to date. In addition they reviewed and approved the FY 05–06 budget which like this year is forecast to break even. The financial status of the chapter is sound with over \$4600 in our scholarship fund, \$20,000 in our Solano Breeding Bird Atlas fund, and over \$10,000 in our unallocated fund. In addition we have over \$6000 in our interest bearing checking account; expenses and income balance at about \$9,000 each per year.

The Board voted to combine the nomination and election meeting with the May general meeting each year. The December general meeting was eliminated, with everyone encouraged to participate in and attend the CBC compilation, in lieu of a general meeting. In addition, the traditional "bring your slides, CDs, and birding experiences to share potluck" will be held in June each year with no speaker scheduled. The board also changed the bylaws to require the Vice President to hold the Program Chair or another open committee Chair.

The Board added a new Committee – the Communications Committee. Its duties include maintaining a registered, hosted website or future equivalent, which will contain information on the meetings, field trips, projects, and officers of NSAS. In addition the website may contain links, pages, and announcements that support the purpose and objectives of NSAS and National. The committee was tasked to continue to seek up to date, cost effective means of disseminating information about NSAS to the public and membership. It was stated in the change that as long as any member specifically requests information by means other than electronic dissemination, the committee shall maintain a mailing list for those members and mail information on chapter events not less than quarterly to those members who have made such a request. Dave McMullen volunteered and was selected to be the initial Communications Chair.

The board discussed providing board members with standardized up to date software to assure good communication and efficient data sharing. To meet that goal Microsoft Office Pro multiple use licenses with two year free upgrade for both Pcs and Macs were authorized. Previous research had determined charity organization license rates were available to the chapter and a vender was chosen <u>www.zonescs.com</u>. As a result beginning with FY 05 –06 all board members will have up to date software provided to assist them in doing chapter business.

This is my last column as President. I have enjoyed the challenges of the job. All the success of this past year is due to the hard work and dedication of the Board and membership of the Napa Solano Audubon Society. I will continue to volunteer but now my focus will be on the Portland Oregon Audubon Society where we are moving this June to live near my daughter, son-in-law and one of my wonderful grandchildren. May you continue to grow and succeed in your goal of "Being the best birding and conservation organization in Napa and Solano counties".

From afar, we also got to briefly study an active rookery of egrets (most likely Great Egrets). Pelicans flew around us constantly and we patiently awaited for fleeting (but treasured) glimpses of the Common Yellowthroat and Marsh Wrens. About a dozen elk were easily visible from the road at one of our last stops.

In total, over 40 species were seen, and there were many opportunities to study the various waterfowl on the shallow lakes and sloughs throughout the refuge.
